Whereas, the Ministry of Information and Broadcasting (MIB) vide its Advisory dated 31/05/2022 (copy enclosed) informed all the Multi-System Operators (MSOs) that monitoring devices are to be installed on the Head-end of the cable operators under the provision of sub-section 4 of Section 10A of the Cable Television Networks (Regulation) Act, 1995 for monitoring of output feed;


2. And whereas, MSOs were also requested to furnish information regarding head-end locations, Conditional Access System, Transport Stream/Frequency detail, RF Feed Details, Platform Service details etc. to BECIL official/team and to furnish above information at www.digitalindiamib.com;

3. And whereas, it was observed that some of the MSOs failed to get themselves registered and furnish above information on the portal. Therefore, this Ministry vide order dated 15/11/2022, followed by another order dated 24/11/2022 (copy enclosed) directed all MSOS to get themselves registered on www.digitalindiamib.com and furnish requisite information till 02.12.2022;

4. And whereas, it has been observed that some of the MSOs have still not got themselves registered on the aforesaid URL and furnished the requested information;

5. Now therefore, in exercise of powers conferred under Rule 10 A of the Cable Television Networks Rules, 1994, all the MSOs are hereby informed that the last date for registration on www.digitalindiamib.com has been extended upto 16/12/2022. This may be treated as final opportunity to furnish the requisite information;

6. It is reiterated that failure to furnish above information within the prescribed time limit shall be construed as violation of terms and conditions of MSO registration. It may lead to the initiation of proceedings under Section 4(7) of the Cable Television Networks (Regulation) Act, 1995 and Rule 11(7) of the Cable Television Networks Rules, 1994 for the suspension/revocation of MSO registration.



3. And whereas, it was observed that some of the MSOs failed to get themselves registered and furnish above information on the portal. Therefore, this Ministry vide order dated 15.11.2022 (Copy Enclosed) directed all MSOs to get themselves registered on www.digitalindiamib.com and furnish requisite information till 25.11.2022.

4. And whereas, it has been observed that some of the MSOs have still not got themselves registered on the aforesaid URL.

5. Now, therefore, in exercise of powers conferred under Rule 10A of the Cable Television Networks Rules, 1994, all the MSOs are hereby informed that last date for registration on www.digitalindiamib.com on has been extended upto 02.12.2022. This may be treated as final opportunity to furnish the requisite information.

6. It is reiterated that failure to furnish above information within the prescribed time limit shall be construed as violation of terms and condition of MSO registration. It may lead to the initiation of proceedings under Section 4(7) of the Cable Television Networks (Regulation) Act, 1995 and Rule 11(7) of the Cable Television Networks Regulation Rules, 1994 for the suspension/revocation of MSO registration.


2. And whereas, MSOs were also requested to furnish information regarding head-end locations, Conditional Access System, Transport Stream/Frequency detail, RF Feed Details, Platform Service details, CTAV Signal distribution areas, STB Seeding details etc. to BECIL official/team for monitoring system;

3. And whereas, all the MSOs were informed through email that a URL (www.digitalindiamib.com) has been created by BECIL for furnishing of the above-mentioned information;

4. And whereas, it has come to the notice of the Ministry that some of the MSOs are yet to get registered and furnish the information on the portal;

5. Now therefore, in exercise of power granted under Rule 10A of the Cable Television Networks Rules, 1994, all the MSOs are hereby directed to get themselves registered on www.digitalindiamib.com and furnish the requisite information on or before 25.11.2022.

6. In case of failure to furnish the above requested information within the prescribed time limit, it may be construed that MSO has violated the terms and conditions of Registration granted to them. Further, it may lead to the initiation of proceedings under Section 4(7) of the Cable Television Networks(Regulation) Act, 1995 and Rule 11(7) of the Cable Television Networks Rules, 1994 for the suspension/revocation of the MSO Registration.



ADVISORY

In order to ensure adherence to the provisions of Cable Television Networks (Regulation) Act, 1995 and Rules made thereunder, it has been decided, with the approval of the competent authority, to monitor output feed of cable operators through a monitoring device. The monitoring devices are to be installed on the Head-end of the Cable Operators, under the provision of Sub-Section 4 of Section 10A of the Cable Television Networks (Regulation) Act, 1995.

2. Accordingly, Cable Operators are requested to cooperate with officials / team of BECIL visiting their premises for installation of monitoring devices on their Head-end. It is also requested to furnish the requisite information regarding Head-end locations, Conditional Access System detail, Transport Stream / Frequency detail, RF Feed details, Platform Service details, CTAV Signal distribution areas, STB Seeding details, etc., required by BECIL officials / team for monitoring system.

3. Any non-cooperation will be viewed as violation of sub-section 4 of Section 10A of the Cable Television Networks (Regulation) Act, 1995. Such violations may invite action as per the provisions of the Cable Television Networks (Regulation) Act, 1995 and Rules made thereunder.
