In order to implement Digital India Initiative, Government of India has launched "Online Non-Tax Revenue Portal (NTRP) for collection of Non-Tax Revenue Receipts". All Broadcasters/ Teleport operators/News Agencies are therefore, required to remit all payment pertaining to this Ministry from 01st January, 2017 in electronic mode (Credit Card/Debit Card/Net Banking/RTGS/NEFT) only and not in physical form of payment (Bank Draft/Cheque).

For making payments through NTRP, all Broadcasters/Teleport operators/News Agencies may visit the page <u>https://bharatkosh.gov.in</u>. Payment may be made either after registration or without registration. User guide is available under the link <u>https://bharatkosh.gov.in/Static/Template/UserGuideBharatkosh.pdf</u>. This Ministry has allocated relevant heads of account for making payment, such as:

- a. For making payment of Rs. 2 lakh towards annual uplinking fee of TV channels, the head "Permission fee of TV channel for Uplinking from India" would be used.
- b. Similarly for paying Rs. 5.0 lakh towards annual downlinking fee, the head "Permission Fee of TV Channels for Downlinking from India" would be used.
- c. For payment of Rs. 15.00 lakh towards annual Downlinking fee uplinked from abroad, the head "Permission fee of TV Channels for Downlinking from abroad" would be used.
- d. For making payments towards requests for changes in channel name and/or logo, teleport, satellite etc, the head "Processing fee for various changes in permitted TV channel" would be used.
- e. For Fresh or Additional TV channels/ Teleports/ News Agency applications, respective "Processing fee" head would be used.
